1. Tanzania Posts Corporation has received funds from the Universal Postal Union (UPU) under Project Number QSFTZA2511 for the procurement of motor vehicles for enhancement of intra-town mail delivery for quality mail services in Dar es Salaam for the financial year 2025/2026.
2. The Corporation now invites eligible and qualified bidders to submit bids for the supply of motor vehicles in accordance with the Public Procurement Act and its Regulations, using the National e-Procurement System of Tanzania (NeST)
3. The scope of this tender includes the supply, delivery, inspection, testing and commissioning of brand new motor vehicles to support enhancement of intra-town mail delivery services in Dar es Salaam as detailed below:

4. All vehicles shall be brand new, unused, and shall comply with the technical specifications provided in the bidding documents.
5. Bidders shall be eligible as defined in the Public Procurement Act and its Regulations and must be registered on the National e-Procurement System of Tanzania (NeST).

7. Bids must be submitted electronically through the National e-Procurement System of Tanzania (NeST) at [www.nest.go.tz](http://www.nest.go.tz). Manual submission of bids, physical envelopes, email or fax submissions shall not be accepted
8. All bids must be accompanied by a Bid Security equivalent to two percent (3%) of the total bid price, in the form specified in the bidding documents, and submitted electronically through the NeST system.
9. The deadline for submission of bids shall be as indicated in the National e-Procurement System of Tanzania (NeST). Bids will be opened electronically immediately after the deadline in accordance with NeST procedures.
